

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT IN CONSIDERATION of Mountain Biking Worldwide Ltd and SriLankan Airlines considering my entry form to participate in or permitting me to participate in any way in any of the Mountain Biking Worldwide Ltd and SriLankan Airlines tours, holidays and events including but not limited to Ride SriLankan 2027, under the umbrella ("the Tours").

I, on behalf of myself, my legal personal representatives and assigns:

1. ACKNOWLEDGE that a) Mountain Biking Worldwide Ltd and SriLankan Airlines conducts the Tours using largely, if not completely local logistics partners and b) that it is a requirement of participation and my responsibility to obtain appropriate insurance for my circumstances, appropriate for the Tour, the country it is conducted in (in this case Sri Lanka) and any activities undertook on the Tour and for the duration of the Tour including, with a minimum cover of, 24 hour emergency cover from the insurance provider for emergency health and medical treatment expenses, emergency evacuation, personal liability, personal accident cover and repatriation costs. That it is also advisable for me to have insurance cover for the following: trip cancellation and curtailment, travel delay and holiday abandonment, baggage, gadget, and sports equipment. I am aware that this list is not exhaustive.

2. ACKNOWLEDGE that I have sufficient bicycle riding/hiking/running/ experience on a mixture of outdoor trails and terrain, in good health and in proper physical and mental condition to be able to participate in such activities as the Tour and that I have made full written disclosure to Mountain Biking Worldwide Ltd of any medical condition I have or medication that I may use.

3. ACKNOWLEDGE that the Tours will be conducted in a field environment that may be some distance from medical assistance, over public roads and trails, through wilderness with limited water supplies, where there are potential hazards including, without limitation; other participants in the Tour, uneven and changeable terrain, loose dirt and gravel, rocks, trees, tree stumps, branches, other road users driving cars, motor bikes, cycles, motor vehicles and other vehicles, hikers, the risk of wild or domestic animals, inclement and changeable weather, the risk of natural disaster and the risk of fire.

4. ACKNOWLEDGE that if at any time, I believe conditions to be unsafe, I will immediately discontinue participation in the Tour in the safest way possible, only after first advising Mountain Biking Worldwide Ltd and subject to the direction of Mountain Biking Worldwide Ltd.

5. ACKNOWLEDGE that any equipment and apparel provided by me for my own use or any other person's use is fit for the purpose of the Tour, such equipment and apparel including, without limitation; bicycles, parts, helmets, clothing, shoes, and other safety equipment. I agree that any damages to personal equipment and apparel is left entirely at my own costs, regardless of how this was encountered. Mountain Biking Worldwide Ltd and SriLankan Airlines will not be responsible for any loss, damage or accident to any luggage and property. Mountain Biking Worldwide Ltd has advised me to check the limitations of insurance policy in this respect.

("Risks"), a) the Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Tour, the field environment in which the Tours are taking place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW, b) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time, and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation in any of the Tours.

8. RELEASE, DISCHARGE AND COVENANT NOT TO SUE Mountain Biking Worldwide Ltd or SriLankan Airlines, its respective administrators, contractors, directors, agents, officers, members, volunteers, employees, other participants, sponsors, advertisers and, if applicable, owners, lessors or occupiers of land and premises on which the Tours take place, (each considered one of the "RELEASEES") FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BECAUSED IN WHOLE OR PART BY ME, THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, INCLUDING WITHOUT LIMITATION, NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, costs on a full indemnity basis, any judgment, loss, liability, damage, or cost which any Releasee may incur as a result of such claim; AND I HAVE READ THIS AGREEMENT, FULLY UNDERSTOOD ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE BY ANYONE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE OF THIS AGREEMENT SHALL CONTINUE IN FULL FORCE AND EFFECT.
